# Title

'New Femininities', Alcohol Consumption and life Beyond Young Womanhood. Negotiating Gender, Class and Age-appropriate Identities through Alcohol Consumption

Constructions of acceptable drinking are intimately intertwined with gender. Whereas women's alcohol consumption and nightlife participation traditionally has been considered problematic, it has to a large degree become normalised and expected over the last decades. However, research in this field has demonstrated that women today are negotiating contradictory expectations of drinking and going out more similarly to men, while simultaneously adhering to conventional ideals of femininity by remaining more in control over intoxication, safety, and sexuality. In other words, women are navigating both newer and more conventional ideals of femininity as they drink and go out.

In her doctoral thesis, Ph.D.-candidate Kristine Vaadal explores the meaning of alcohol in the lives of women in their late twenties and early thirties. In four published articles different aspects of alcohol consumption and nightlife participation are explored, based on in-depth interviews with women aged18-34.

The doctoral thesis demonstrates that the women's alcohol consumption should be understood as embedded in broader life projects, related to lifestyle and career, and in light of their imagined future lives as adult women. The study shows that ideals of femininity change with age, and that gender must be re-negotiated considering new life-phases. This is reflected in the women's drinking practices. As part of growing older, the women interviewed in this study described both new ways of participating in nightlife, as well as an increased importance of the domestic sphere. Moderate, frequent, and sophisticated drinking and nightlife practices could be presented as both empowered and respectable for the participants in this study, thus enabling new drinking practices and ways of participating in nightlife. However, sexual agency in nightlife became more difficult with age and limited their autonomy in nightlife in new ways.
